## Covenants: Protecting You and Your Investment

2016 was a big political year. And we hope that each of you took time out to vote. However, we would like to remind everyone that we do have restrictions on the type of signage that can be displayed throughout the neighborhood.

"A sign denoting the street address of the residence located and designed in accordance with approved standards, shall be required on each Dwelling Unit. In addition, one small sign may be used to denote the name of the resident, subject to the prior written approval of the Association with regard to size, shape, design, color and location of such sign. No other signs or any kind shall be displayed to the public view on any Lot, Dwelling Unit, or any vehicle parked on any part of the Property; provided, however, that nothing herein shall be construed to restrict in any manner the Developer from placing signs and advertising on the Property or any portion thereof."

This is not to impose any political belief on anyone nor restrict anyone's beliefs. This clause in the covenants was developed in order to prevent hard feelings between neighbors and to maintain property beautification.

Another thought on being a good neighbor is how we, as residents, use Windance Golf Course. We must remember that as residents, we are not automatically members of the golf course; you must join for a separate fee. Island View and Windance members have been good neighbors to us and we should reciprocate. Many residents own golf carts and like to drive on the course. Be advised, security will stop you and ask you to leave. Members pay \$600.00 a year to drive on the cart paths. If you want to take advantage of a wonderful tract of property, please be cognizant of the golfers. Additionally, please be aware that the golf course is not a soccer field and it is not bike track to race on. Please respect the property of our neighbors as they have ours. The course is closed on Mondays and some may want to go out there then; but the grounds crew is out there working hard.

**Speed Limit** – Windance is a 20 mph speed limit zone. Please help us keep our children and neighborhood safe by watching your speed.




