The camera system we currently have at the front of the neighborhood is not working properly. Bradley made a motion to cancel our current subscriptions to Arlo and AT&T. This motion was seconded and approved by the board.

Bradley suggested we get updated technology and cameras throughout the neighborhood. We will leave the current cameras at the front of the neighborhood for now, but we will update the cameras and services as soon as possible.

Tyler shared there is a dead pine tree that needs to be cut down on Balata. Tyler will get a quote and see how quickly we can get the tree cut down.

Paul brought up that lots of folks in the neighborhood have been complaining about solicitors in the neighborhood. Bradley reminded everyone to encourage neighbors to call the Sheriff's Department the next time they see solicitors in the neighborhood.

Mrs. Ann reminded everyone to keep her informed about homes in the neighborhood for sale.
